

PRIVACY POLICY AND TERMS OF USE OF THE WEBSITE <https://puls.ua/>

LLC "PULS SIMEINA KLINIKA" has developed and publishes this **privacy policy and terms of use of the website <https://puls.ua/>** (hereinafter referred to as the privacy policy and conditions) in order to avoid any misunderstandings and conflicts with visitors.

In particular, this PRIVACY POLICY AND TERMS OF USE OF THE WEBSITE <https://puls.ua/> explains what types of information "PULSE SIMEINA KLINIKA" LLC can collect and store. Also LLC "PULS SIMEINA KLINIKA" notes how this information can be used and provided.

1. The visitor cannot use this site incorrectly. In particular, the visitor should not influence or interfere with the operation of this site or access the information published on this site other than through a standard interface.
2. The visitor should use this site exclusively in accordance with the current legislation of Ukraine. If the site administration discovers a visitor's violation of this PRIVACY POLICY AND CONDITIONS, or suspects the visitor of this, it may suspend or completely close the visitor's access to the site.
3. "PULSE SIMEINA KLINIKA" LLC may revise this PRIVACY POLICY AND TERMS at any time.
4. Collection and use of personal data:
 - 4.1 Personal data is information or a set of information about an individual who is identified or can be specifically identified.
 - 4.2 Personal data can be obtained through various communication channels. In particular, through the service of website visitors, in writing or electronically on the website.
 - 4.3 The visitor on the website <https://puls.ua/> may be asked to enter personal data if he has his consent. In particular, you may be asked to enter your first name, last name, email address, phone number, date of birth. LLC "PULSE SIMEINA KLINIKA" may contact the site visitor with a request to provide other data.
 - 4.4 When registering on the site <https://puls.ua/>, the visitor agrees to "PULS SIMEINA KLINIKA" LLC to process his personal and registration data. If the visitor decides to provide his personal data, he thereby consents to the transfer and storage of this data.
 - 4.5 LLC "PULSE SIMEINA KLINIKA" may collect data on visits to the site or connections that go through the site. This information can include connections, traffic, date and time of the duration of the Internet.
 - 4.6 Personal data of visitors is used to ensure the exchange of information, relations in the field of advertising and communication in accordance with the Laws of Ukraine "On the Protection of Personal Data", "On Information", "On Advertising", "On Telecommunications", "On Entrepreneurship", "On information protection in information and telecommunication systems", ND TZI 2.5-010-03" Requirements for the protection of information on a WEB-page from unauthorized access", as well as the Charter of "PULSE SIMEINA KLINIKA" LLC and regulations governing the activities of "PULS SIMEINA KLINIKA" LLC
 - 4.7 Personal data of visitors can be stored for 3 years after the personal data is not a visitor to the site <https://puls.ua/>.
 - 4.8 The server of "PULSE SIMEINA KLINIKA" LLC temporarily registers the domain name or IP address of the visitor's computer, as well as the access date, files (file name and URL), HTTP response code and the website from which the visitor got to the site <https://puls.ua/>, the number of bytes transmitted during the session.

4.9 The website <https://puls.ua/> uses cookies. With their help, it is possible to identify the visitor's browser. These files can store user settings and other information. The visitor can configure the browser in such a way as to reject all cookies or to notify about their sending.

4.10 Cookies are used to make the site <https://puls.ua/> safe, secure and user-friendly. Cookies support security features and enable them. Cookies also allow us to track violations of the PRIVACY POLICY AND TERMS by visitors or devices. Cookies help to estimate the number and frequency of requests, as well as to identify and block those visitors or devices that are trying to perform batch downloads of information from the website.

4.11 Using the Google Analytics system, "PULS SIMEINA KLINIKA" LLC collects statistics on visits to the site <https://puls.ua/>, such as pages visited, the number of page views, information that has been downloaded, domains of Internet providers and countries of origin of visitors, as well as the addresses of websites that were visited before and after the site <https://puls.ua/>, etc. None of these actions are personally related to the visitor and are measured only in aggregate.

4.12 Persons under the age of 18 are not allowed to use any services on the website <https://puls.ua/>, in particular, registration. LLC "PULS SIMEINA KLINIKA" will never intentionally collect data about minors, will not use them, and will not disclose them to a third party without appropriate permission. LLC "PULS SIMEINA KLINIKA" advises parents and guardians to keep track of which sites their children visit.

4.13. The site https://puls.ua / can use the Google Project Shield DDOS protection service. This means that Google Inc. process the data collected in the course of Project Shield in accordance with the [privacy policy of Goolge](#) Inc.

6.1 These modules can be buttons for synchronizing an account on the site <https://puls.ua/>, Like, Share or, respectively, "Like". If a visitor opened one of the web pages equipped with such a plug-in, his Internet browser will directly connect him to the servers of Facebook, Twitter, LinkedIn, VKontakte or Youtube. The plugin will send data to the server about which web pages of the site <https://puls.ua/> the visitor viewed.

6.2 When using any functions of the plugin, this information will also be synchronized with the visitor's account on Facebook, Twitter, LinkedIn, VKontakte, Google+ or Youtube. 6.3 In order to avoid linking the networks Facebook, Twitter, LinkedIn, VKontakte, Google+ or Youtube with the site <https://puls.ua/> and then associating this information with the account, the visitor must log out of the network account before visiting the site <https://puls.ua/> .
